

**AMENDMENT NO. 1 TO THE AGREEMENT  
BETWEEN THE CITY OF SAN MATEO AND  
SAN MATEO UNION HIGH SCHOOL DISTRICT  
FOR AFTERSCHOOL ENRICHMENT SERVICES FOR EMPOWERMENT THOROUGH ACTION  
PROGRAM FOR FISCAL YEAR 2024-2025  
(\$31,000 [Original Amount], \$48,000 [Amendment 1])**

WHEREAS, the City of San Mateo ("City"), a municipal corporation of the State of California, and San Mateo Union High School District, a Public Educational High School District, ("CONTRACTOR"), entered into an Agreement for afterschool enrichment services for Empowerment Through Action Program for Fiscal Year 2024-2025 Agreement on September 11, 2024; and

WHEREAS, City and San Mateo Union High School District wish to amend the Agreement amount by \$17,000, for a total Agreement amount of \$48,000 for Fiscal Year 2024-2025.

NOW, THEREFORE, the parties agree as follows:

1. Exhibit A, #1. of the Agreement is amended to include:

"1. The CONTRACTOR agrees to provide enrichment activities (i.e., basketball, soccer, dance, etc.) at select high schools located in the SAN MATEO UNION HIGH SCHOOL DISTRICT to be mutually agreed upon between CITY OF SAN MATEO representative and CONTRACTOR or their designee. The CONTRACTOR agrees to provide a Bridge to Bridge Program Coordinator at select high schools in SAN MATEO UNION HIGH SCHOOL DISTRICT whose hours will be mutually agreed upon between CITY OF SAN MATEO representative and CONTRACTOR or their designee."

Exhibit B:

"The total cost for this contract shall not exceed \$48,000 for the length of the contract. Fees for activities must be mutually agreed upon by both parties in writing a minimum of two weeks in advance of implementation."

2. The remaining terms of the Agreement remain in full force and effect.
