I wanted to write a brief letter in support of Adam Nugent's reappointment to the San Mateo Planning Commission for another term. Over the last several years, Adam contributed to the development of our city's housing element and design standards, and currently serves as Vice Chair. While there has been a relative lull at the Planning Commission since the latter half of 2024, my expectation is that this will soon change as a significant number of building applications make their way through the planning process. As we begin to see those projects in front of the commission, I believe that Adam's expertise and tenure on the commission will be an asset to our deliberations and the commission's ability to respond in a constructive way to community concerns. On May 7th, Mayor Rob Newsom joins councilmembers Cwirko-Godycki, Fernandez and Loraine to interview prospects for the Planning Commission. One of them is "No Ethics" Nugent, a currently serving Planning Commissioner, reinterviewing to stay in his seat. Does he deserve it? NOPE.

So, what happened to Commissioner Nugent for this audacious act? Nothing. Maybe the City was busy trying to convince the State that Nugent's PowerPoint shouldn't override their own, but more likely it was due to his Council cronies wanting Nugent to remain in his seat. No slap on the wrist, no removal, no nothing. (FYI: It takes 4 Council votes to remove a commissioner.)

Parents know when bad behavior goes unpunished, a child will feel emboldened and repeat the pattern.

Fast forward to October 2022 when Nugent's next move was referred to the District Attorney.\*

Let's talk about campaign tampering. Political campaign signs are a form of speech protected under the First Amendment - but that didn't matter to Nugent. He removed campaign signs. More specifically he removed only Rob Newsom's signs, a council candidate he did not support - and left others alone. Trouble was, it was caught on camera. It was only when radio station KCBS called Nugent that he admitted what he had done - but because he thought the signs were placed improperly, he said. Which makes zero sense as to why he would not take the adjacent signs. I guess he hoped we'd all buy his story.

Nugent did a little dance, as did his Council supporters when Councilmembers Papan and Rodriguez urged there be a fact-finding investigation to satisfy the public outcry. The San Mateo Police Department looked into

the matter and the Chief reported it had "resulted in sufficient criminal evidence that the case has been forwarded to the DA."

A normally good-natured Rob Newsom (now our Mayor) responded:

"This (sign stealing) story has been airing all day today on KCBS Radio. On May 7th, Mayor Rob Newsom joins councilmembers Cwirko-Godycki, Fernandez and Loraine to interview prospects for the Planning Commission. One of them is "No Ethics" Nugent, a currently serving Planning Commissioner, reinterviewing to stay in his seat. Does he deserve it? NOPE.

I bring you back to the recent history of 2022, when City Hall was filled with ne'er-do-wells who did what they wished, including Planning Commissioner Adam Nugent. He relied on 3 friends on the Council who consistently chose to look the other way.

In November of 2022, then Councilmember Eric Rodriguez joined Diane Papan in asking for an investigation of Nugent after the second time he went rogue that year:  
"Public confidence in San Mateo's Planning Commission is falling fast and might be at an all-time low."

So, what did Nugent do?

He did this working from his City email, trampling all over City staff who'd spent years working to comply with the State's housing mandate. Nugent's dismantling handiwork, completely out of line with his duties, was meant to effectively convince the State to place San Mateo in the crosshairs of unchecked development.

So, what happened to Commissioner Nugent for this audacious act? Nothing. Maybe the City was busy trying to convince the State that Nugent's PowerPoint shouldn't override their own, but more likely it was due to his Council cronies wanting Nugent to remain in his seat. No slap on the wrist, no removal, no nothing.

(FYI: It takes 4 Council votes to remove a commissioner.)

Parents know when bad behavior goes unpunished, a child will feel emboldened and repeat the pattern.

Fast forward to October 2022 when Nugent's next move was referred to the District Attorney.\*

Let's talk about campaign tampering. Political campaign signs are a form of speech protected under the First Amendment - but that didn't matter to Nugent. He removed campaign signs. More specifically he

removed only Rob Newsom's signs, a council candidate he did not support - and left others alone. Trouble was, it was caught on camera. It was only when radio station KCBS called Nugent that he admitted what he had done - but because he thought the signs were placed improperly, he said. Which makes zero sense as to why he would not take the adjacent signs. I guess he hoped we'd all buy his story.

Nugent did a little dance, as did his Council supporters when Councilmembers Papan and Rodriguez urged there be a fact-finding investigation to satisfy the public outcry. The San Mateo Police Department looked into the matter and the Chief reported it had "resulted in sufficient criminal evidence that the case has been forwarded to the DA."

A normally good-natured Rob Newsom (now our Mayor) responded:

"This (sign stealing) story has been airing all day today on KCBS Radio. As a Personnel Board Commissioner, I am saddened that a fellow City Commissioner (Adam Nugent) would take it upon himself to remove/steal my signs in broad daylight- with his child in-tow. I had hoped that he would just come forward and apologize. He has not."

So, what do we want? Ethics? Social media screams for it all the time. Ethics San Mateo, a citizen group, was formed in October 2022 due to much of this nonsense, but not surprisingly got no traction with our then-Council.

But here is the GOOD news. Our current Council is slated to review recommendations by Ethics San Mateo to strengthen and support ethical conduct in City Hall - INCLUDING COMMISSIONERS. But let's go one better - Let's CLEAN HOUSE.

People like Adam Nugent have been allowed to sit in important seats and make decisions for us all when it's very clear HIS decision-making is questionable at best. While time may have dulled the bite of Nugent's brazen actions and his cronies have since fallen mostly by the wayside, Councilmember Rodriguez' words about public confidence should still be ringing loudly.
