Hello all City Council Members, Mayor and Vice-Mayor. First, I'd like to thank all of you and the entire staff in the City Office who have been working so hard on retail reopening and in my case, restaurant reopening. You've heard the stories of the layoffs and furloughs and pay cuts. We have been affected just like other small businesses all over the city, county, country and world. I believe it will take a superhuman effort to pull us out of this mess so most of us are standing when this is all over. We certainly plan to be one of those that plan on being around for many years but we need some more help. I have been on city restaurant reopening calls a few times. Both Jennifer and Kathy are doing an amazing job. Kudos to them. In my opinion, this is the time for humanity to come together and do more than ever before for each other and shove aside any politics for the greater good. I have the utmost faith in the council and the city staff and am very thankful to have been included on the reopening calls.

I list below what I think would work best on some streets in Downtown San Mateo:

- Close B Street between 1st and 2nd and even 2nd & 3rd. The most amount of restaurants live on these segments of the street. I don't understand why B is being shut where Wursthall and Jeffrey's are. We need to bring vibrancy back to Downtown. Closing 3 blocks is better than closing 1 block that is so removed from the heart of B street. I am not sure who this closure benefits except Wursthall, China B, Jeffrey's and the Poke place. Further, this closure will definitely take away from restaurants between 1st and 2nd. The 'action' will be happening on a small block a block away, clearly benefiting a handful of select restaurants. Why was this street chosen to be closed? If we want this to work, we want B street to be vibrant and looking hospitable for a few blocks and if anything, not a corner block. I think it's a great idea to shut traffic on streets but I don't think it's a good idea to shut just that block. There are some residents on these blocks. We can close at 9p on weekdays and 10p on weekends, thus eliminating noise during quiet hours. There seems to be a concern about delivery vendor parking. This seems to be a very easy problem to solve with dedicated temporary parking and instructions from restaurants on where to park and how to pick up that get embedded permanently on driver instructions in the apps. I work very closely with these delivery vendors nationally and have been amongst the 1st ten restaurants they signed up when delivery became a thing beyond Pizza. I know that business very intimately and am sure this isn't a problem some are making it out to be
- We need permanent parklets setup. This could be at the expense of the business or a joint effort but if COVID is going to last as long as it is or is going to have a 2nd wave as some say, shouldn't we be planning for this like some other cities have? Our sidewalks aren't broad enough for outside seating. While I think the temporary parklets are a good and solid start, over time, we will see that individual parklets will work better, are safer and more appealing to restaurant guests and add so much character to the street. I am willing to be a test pilot if there's an appetite for this. At this time, Palo Alto is testing 2 such parklets
- Open up Main Street Dining. Philz, CurryUpNow and 2 other residents backup to Main Street. There is no benefit for our bar, Mortar & Pestle with the B street closure. That business is seen as a stand-alone brand, even though it's part of CurryUpNow. We can easily seat guests outside our space and our landlord's, thus maintaining distancing and also not encroaching upon Main Street. This should be done between 1st 3rd all the way from Philz to Pacific Catch. Let's welcome some of our retail vendors to setup pop-ups on Main Street from time to time or on weekends. Main Street is a beautiful street and can become so much more functional and vibrant if outside seating were allowed. There are enough businesses on this street that will benefit from this. We can even do permanent night market style weekends on this street
