Dear Mayor Goethals & City Council members Bonilla, Lee, Papan, and Rodriguez,

Per the Elections Code, San Mateans for Responsive Government (SMRG) will be submitting the **primary argument in favor** of our measure. We will also submit the **primary argument against** the competing measure.

Background:

SMRG members watched the June 29th council meeting and took particular interest in your discussion of whether the Council itself would write any of the ballot arguments about the two planning measures. We understand that you decided that the Council will NOT write a **primary argument in favor** of either of those two measures.

You then discussed the **primary ballot arguments against** each of the measures. In the end, you stated that the Council would not draft any such argument but seem to have left that decision open until the July 20th meeting to get feedback from the two groups who circulated the petitions. You expect that these two groups will write those arguments, and asked that interested parties contact the city with their intentions.

San Mateans for Responsive Government will be submitting the **primary argument in favor of** our measure, in accordance with the Elections Code. The Council agreed that it is only logical that the group that originally circulated the competing measure will submit the **primary argument in favor** of that one. This symmetry and fairness makes logical sense.

That same symmetry, fairness, and logic also apply to the **primary arguments against** each of the measures. San Mateans for Responsive Government will be writing and submitting the **primary ballot argument against** the competing measure.

As provided in the Elections Code, the text of both arguments will be delivered to the City Clerk by the 5PM deadline on Friday, August 14th.
