Health Order Update

- August 2nd: County on State watchlist for >3 days
 - Requires shutdown of indoor operations for:
 - Gyms and fitness centers
 - Personal care services like nail salons
 - Hair salons and barbershops
 - City has set up guidelines for these businesses to operate outdoors
 - Permits available for gyms to hold classes at City parks
 - Standards for personal care services/salons

Public Health Order Enforcement

- August 4th: County Supervisors approve citations for health order violations
 - Applicable to individuals and businesses
 - Requires written warning before issuing citation
 - City personnel authorized to issue citations
 - Code Enforcement Officers
 - Park Rangers
 - Police Officers
 - Community Services Officers
- Provides another tool to supplement educational efforts
- Still developing implementation plan

Operational Update

- Parks and Recreation

- Support for distance learning

- Full day program at King Center for most vulnerable families

- Expected to serve 60-72 children; breakfast and lunch provided

- Net cost to General Fund approximately \$52,000 in order to make program accessible

- Initial program session from August 17th to October 9th

- Afternoon program at Beresford begins September 8th

- Senior Center being held for HS students and overflow from King Center

- Expecting to serve up to 100 K-5 children and a small number of HS students

- High likelihood that some level of program will need to continue even with the return of on-campus learning

Operational Update

- Parks and Recreation
 - Outdoor use by private businesses
 - Six inquiries from fitness providers for alternative locations
 - Two permits issued so far
 - Athletic field adult drop-in use remains problematic
 - Particularly at King, Los Prados and Fiesta Meadows Parks
 - New rules prohibit large group play except by permit
 - Drop in use limited to small groups (7 or less)
 - No spectators
 - Permitting additional youth sports practices on weekends
 - Monitoring park usage at Parkside Aquatic Park for possible overcrowding

Operational Update

- Public Works
 - Installed Safe Street layout on Claremont from Poplar to Tilton (July 23rd)
- Library
 - Began curbside service at branches August 17th
 - Storytimes at the Park extended through end of October
- Community Development
 - Code Enforcement continuing to monitor businesses for health order compliance

Operational Update

- City Manager's Office
 - Parklet survey to businesses to determine interest in making more permanent
 - Staff will return to Council in October for study session
- Police Department
 - Regular passing checks have been scheduled for areas where violations are most likely to occur
 - Focus on large groups and education
 - Officers have masks to provide to individuals as needed

Council Confirmation

- Council confirmation requested for actions taken in response to local emergency proclamation
 - Temporary suspension of municipal code for personal services and fitness businesses
 - Parking requirements
 - Limitations on outdoor activities
 - General Fund subsidy for support of distance learning
 - Approximately \$52,000 through October 9th
