Hi Andrea,

This is why this requirement would be challenging for us and for other restaurants:

1. We have never found any compostable containers that hold the liquids well, which don't leak, and that seal well.
2. Cost: compostable containers are more expensive than plastics.
3. Typically compostable containers are more difficult for our staff to close and to seal properly.
4. Because compostable containers allow the transfer heat much faster than plastic:
  - our employees tend to BURN their hands handling them while the food is still very hot; and
  - customers receive COLDER food because the heat has escaped by the time they receive the food.

I hope that this feedback helps!

**Subject:** Disposable Food Service Ware--public comment

We are so pleased to see this issue being addressed by our city council. With take-out food being the major outlet for restaurants, with the public's strong desire to support local restaurants, and the huge negative impact of plastic on our environment, this issue is very important.

We would without doubt get take out more often if we could identify restaurants who only use compostable fiber-based containers. Last week, I wrote a letter to Thai Charm in San Mateo noting that we would love to patronize their restaurant more but that the plastic was simply too much to accept. The packaging for our dinner for two included NINE separate plastic items, including lids and bags. By comparison, we got lunch for two at another place, Judahlishious, and there was NO plastic. We were offered a plastic bag for a 25 cent surcharge which of course we declined.

While it might be challenging for restaurants to switch to fiber-based compostables, it is a needed requirement. Some restaurants have been successful in making the switch. If it costs a bit more per order, the public would likely be happy to pay if it meant that plastic would be kept out of our waste stream.

Actual recycling of plastic in our county (and really anywhere) is increasingly a myth. Consumers think that recycling their containers solves the problem. But it is clear that virtually none is actually being recycled.

"Compostable plastic" might be the worst culprit because consumers feel it must be better. But of course it's not really compostable. It merely breaks down into tiny individual pieces of plastic that are actually harder to manage and so often end up in waterways.

***San Mateo County's Proposed ordinance of Summer 2019 looks good except for the continued allowance of "compostable" plastic.***

We have to put a value on a clean environment. People have to be willing to pay for a sustainable future, and this is a small price to pay. I think wording might be offered to restaurants who need to pass along any higher costs they incur so they can add it to their bills so the public understands.
