Honorable Council Members:

First, I would like to thank you for inviting the community's input on the matter of introducing semi-permanent or permanent street closures in downtown San Mateo.

I would like to reiterate my support for permanent downtown street closures, preferable exceeding B-Street, since the businesses on B-Street are predominately busy in the evenings and the daytime closure does not benefit them quite as much. Other businesses, for example on 3<sup>rd</sup> Avenue, who have more daytime business, would benefit from street closures, too, especially cafes such as ours, art galleries, retail stores, and street closures for events, such as farmers markets, etc., could potentially attract more retail businesses to fill some of the currently empty retail spaces. A more diverse landscape of retail businesses (not just predominately evening / dinner-type food businesses) would in my opinion bring more foot traffic to downtown.

One obvious concern is the availability of ample parking close to the start points of the respective street closures. With more businesses reopening, parking is likely to become more scarce again.

I would also like to applaud the approval of the permanent parklet program. Backhaus as a business would love to participate in a public parklet program like the one in San Francisco (parklet seating is public and not only available to customers) or a "private" business-specific parklet program.

**Subject:** Downtown Street Closure and Parking Issues - Baldwin Avenue

To Whom it May Concern:

I am the owner of a small family owned locksmith business at 306 Baldwin Avenue in San Mateo. As with other businesses, Covid hurt my retail business too.

At the beginning of the pandemic, I had to close the business for two months. Then, I partially opened up the doors during limited days and hours. The parking on my side of the street was blocked to accommodate the outdoor dining for the two restaurants at each end of the block: ¼ of the street was occupied by "31<sup>st</sup> Union" while "Wursthall" occupied the rest of the block as well as part of B Street along its storefront. My customers were able to park across the street. Several months later, due to the construction at the Trag's site, customers lost their opportunity to park not only across the street, but also on Ellsworth Avenue and on B. Street. I want to bring to your attention that currently, there are two construction/renovation projects taking place within the block. At least two trucks are parked from morning until around 3pm on Ellsworth at the two 24 minute parking spots daily in front of "31<sup>st</sup> Union" with a worker inside, probably counting the trucks at the construction site of the Trag's location. Behind these and across the streets, trucks are parked the whole day for the renovation happening at 250 Baldwin Avenue. Those trucks don't move the entire day. Our customers are complaining that they have to tour around for 15 minutes to find a parking spot to have a key made. It takes 2-3 minutes to cut a key. Who would want to search for a parking spot for 15 minutes for a 2 minute errand?

Recently, "31<sup>st</sup> Union" has closed its doors. "Wursthall" extended its outdoor dining area and is currently occupying the whole block on Baldwin along with the B Street store front for outdoor dining. There are two 24 minute parking meters in front of 302/306 Baldwin Avenue. Can the city please strongly consider releasing those two spots for customer parking? These spots should be reserved for customer parking only and not for construction use. There are no meter maids patrolling the area.
