## OWNER'S CERTIFICATE

We also hereby dedicate for public use all easements for public utilities, anchors and for drainage purposes under, on or over those certain parcels of land designated as "P.U.E.", "A.E." and "S.D.E." respectively on said map within said subdivision; such parcels of land to be kept open and free from buildings and structures of any kind.

We also hereby dedicate for public use easements for wire clearance over those certain parcels of land designated as "W.C.E." on said map within said subdivision. Any structures or appurtenances thereto that lie within such "W.C.E." shall be limited to a maximum height of 15' above lot grade.

The above mentioned "15' Emergency Vehicle Access" shall be open to vehicular traffic only at discretion of the City of San Mateo, and the abutting owners shall have no access thereto without permission of said City.
