## STUDY SESSION

The public will have an opportunity to comment during the consideration of these items.

1. <u>Storm Systems – Funding Analysis Overview</u>

Deputy Director Matthew Zucca provided the history of the Storm Systems Evaluation process. Jerry Bradshaw, Senior Engineer, SCI Consulting, provided information on funding analysis to create an enterprise fund to meet the needs of the storm water system needs. He outlined next steps to consider a Community Survey. Council asked questions of staff and the consultant.

Public Comment - Rich Hedges clarified history of the lagoon. Andrew commented that this is a watershed that feeds to lagoon. James Ruigomez spoke on using prevailing wage for these projects. Rick Sakuda stated it is everybody's rain, the vast majority of the silt comes from the other areas in San Mateo. Lori Middione, Laguna Vista Homeowners Association, talked about needing information on where to haul the dredge.

Council Members commented on the need for a short term and a long-term plan; education needed on this is a vital storm water retention basin and that the benefit of maintaining this accrues to everyone; opportunities to do some work in tandem with the County's Flood Seal Level Rise District; interest in surveying the public similar to the Prop 218 ballots; long overdue and time to move forward; slogan for keep the lagoon blue; and pull in green infrastructure in the fee study. Council concurred the next step is to hear from the community.
