Roxanne Murray Solid Waste Supervisor Annual Rate Review Process

- Council reviews and approves annually
- Rates Cover:
  - Cost of collection
  - Cost of processing and disposal
  - City Fee's
- Effective January 1<sup>st</sup> to December 31<sup>st</sup>
- City elects to follow Prop 218 process



## 2022 Solid Waste Rates Process Review

#### May 2021 Study Session – Council Direction

- 1. Solid waste rates should cover cost of provided services
- Include an estimate of State Bill 1383 (SB 1383) compliance costs in proposed rates
- 3. Develop a one-year rate review plan for Rate Year 2022 with multi-year plan for future years
- 4. Rate Stabilization Fund will be utilized as needed while maintaining a minimum balance
- 5. Consider moving to a 5-year rate structure in 2023

Revenue shortfall will be made up from existing reserves.


Monthly Cost Comparison 2021/2022 Residential Garbage Collection Rates

Size of Collection Cart	2021 Monthly Rate	Proposed 2022 Monthly Rate	Landfill Closure Fee (No Increase, separate line item on customer bill)	Monthly Difference	Total Monthly Cost
20 Gallon Cart	\$15.19	\$19.19	\$0.40	\$4.00	\$19.59
32 Gallon Cart	\$24.29	\$28.29	\$0.64	\$4.00	\$28.96
64 Gallon Cart	\$53.52	\$55.52	\$1.41	\$2.00	\$56.93
96 Gallon Cart	\$85.69	\$87.69	\$2.39	\$2.00	\$90.08

#### Council recommended a not-not-to exceed:

- \$4.00 per month increase for 20- and 32-gallon residential and commercial garbage and organic cart rates;
- A \$2.00 increase for 64- and 96-gallon residential and commercial garbage and cart rates;
- A not-to-exceed two percent increase in commercial waste and organic bin rates.

May 3, 2021: Council Study Session

August 16, 2022: Council approval to mail public notice

August 23, 2022: 45-day public notice mailed

October 18, 2022: City Council Public Hearing

January 1, 2022: Effective
