CITY OF SAN MATEO RESOLUTION NO. ____ (2021)

RESOLUTION TO REDUCE THE POSTED SPEED LIMIT IN SCHOOL ZONES CONSISTENT WITH CALIFORNIA STATE LAW

WHEREAS, the California Vehicle Code (CVC) Section 22358.4(b) grants authority to local jurisdictions to 1) reduce the posted speed limit to 15 mph within 500 feet of school grounds, and 2) extend the 25 miles per hour posted speed limit in school zones from 500 feet to 1,000 feet from school grounds; and

WHEREAS, the reduced speed limits in school zones are consistent with City Council goals and the FY2021-22 Strategic Plan; and

WHEREAS, City Council reviewed the policy parameters and provided direction to staff to implement reduced speed limits in school zones per state law at all qualified roadway segments contiguous to K-12 schools within the City boundary; and

WHEREAS, the reduced speed limits will be in effect while children are going to or leaving the school, either during school hours or during the noon recess period; and

WHEREAS, staff conducted the necessary Engineering and Traffic Studies required for implementation, and identified roadways contiguous to schools that meet the CVC criteria for implementation; and

WHEREAS, following City Council adoption, the appropriate signage will be installed along qualified roadway segments pursuant to the CVC requirements.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN MATEO, CALIFORNIA, HEREBY RESOLVES that:

- 1. In accordance with CEQA Guidelines section 15061(b)(3) and 15301, the reduction of speed limits near school zones is exempt from CEQA review under the "common sense" and "existing facility" exemptions, respectively, because it can be seen with certainty that there is no possibility reducing vehicle speed limits near schools may have a significant effect on the environment and it concerns only minor alterations of an existing street system involving no expansion of use.
- 2. Pursuant to CVC Section 22358.4(b) that 15 miles per hour shall be the prima facie speed limit at a distance within 500 feet of a school boundary and 25 miles per hour shall be the prima facie speed limit at a distance from 500 feet to 1000 feet from a school boundary where applicable on the road segments identified below.
- 3. The speed limits near school zones shall be in effect while children are going to or leaving the school, either during school hours or during the noon recess period.
