



Read your opinion piece in Mondays Daily Journal. We are designers and installers of high efficiency HVAC systems including heat pumps systems. We are located in downtown SM now for just shy of 100 years. No one has inquired of us the wisdom of the proposed Reach Codes, nor the industry groups.

Most older homes will need hybrid systems utilizing gas heat to meet the heating demands of the less insulated older housing stock, using a heat pump for the first stage of heating. Most homes electrical service is not adequate for this need, and unsure if utility can provide the needed power Reach Codes will demand, not to mention charging of electric cars.

Further, you should check with your own building department about ability to locate outdoor equipment, sound levels allowed, and your fee schedule for permits. Hard to imagine why a furnace or water heater replacement permit should cost \$550.00, and with Heat pump with submittal drawings etc, \$750.00. Total cost is over \$1,100.00. So much cost to discourage acceptance, much caused by the city.

I am free to discuss if you wish. Please slow down your rush to electrify. Typical gas furnace we install is either 96% or 99% efficient. Smaller gas furnace size with high efficiency creates less carbon than the replacement Reach Codes will accomplish.



This letter expresses the official position of the San Mateo Climate Action Team (SMCAT) on the outcome of the September 19, 2022 City Council study session on Reach Codes.

We thank the City Council and Staff of San Mateo for taking up the critical, time-sensitive, well-studied and sufficiently outreached issue of Reach Codes for existing buildings in 2022. We are pleased to hear that most of you support the concept of an Electrification Ordinance phasing out methane gas use in homes. This is in line with the overwhelming support that community members have expressed as we have gone door to door and engaged residents throughout San Mateo. The main issue at stake appears to be timing: Staff asserted that much more time is needed to think about action, while SMCAT and over 430 members of the public including many students call for urgent action as the necessary and responsible choice for the City.

Here is what we understood to be the current status of the Council Members' views on Reach Codes for existing buildings as of the conclusion of the September 19, 2022 City Council meeting on Reach Codes:

Mayor Bonilla and Council Member Lee supported SMCAT's request for the City Council to adopt in the Fall of 2022, an ordinance for existing buildings to take effect January 1, 2025, as we have outlined in our <u>Petition for San Mateo Climate Action</u>. The ordinance requires that those homeowners and businesses that replace gas-fired equipment, such as water heaters and furnaces, will receive building permits for electric replacements only (including ample flexibility & exemptions for hardship).

A majority of City Council Members support the Electrification Ordinance but were pressed by Staff to delay action with additional studies and additional outreach on SMCAT's proposed ordinance for **an extra 3-6 months**. In practical terms, what this means is that the current City Council Members will not be able to vote on such an ordinance, and any such ordinance will need to be considered by the next City Council, three members of which will take office on December 5, 20222, with a fourth likely to take office after a public application and selection process.

The Staff approach to study the issue to oblivion is unnecessary and out of step with our City's climate goals. The Electrification Ordinance is critically necessary, time-sensitive, and sufficiently studied and outreached to be adopted **this Fall 2022**.

SMCAT's requested ordinance is critically necessary (see <u>Petition for San Mateo Climate Action</u>).

SMCAT's requested ordinance is time-sensitive for the following two reasons:

According to the IPCC, we have just **7 years** left to emit greenhouse gas emissions at the current rate before going beyond 1.5 degrees Celsius of warming compared to pre-industrial levels; however, all of the existing gas infrastructure on the planet is currently putting us on the path toward a catastrophic 2 degrees Celsius of warming.

Reach Codes are highly technical, nuanced and poorly understood by the uninitiated. The current City Council members understand them thanks to the great work they have done on Reach Codes since 2019. Moreover, the current City Council members understand the call of climate scientists and advocates for swift action (see point #1, above), even if they do not agree on what to do about such calls for action. However, 4 out of the 5 members of the current City Council will leave office at the end of 2022. A virtually brand new City Council will lead our City in 2023. The new Council will be tasked with learning a great deal about a great many policies and procedures right out of the gate, and accordingly, they will be unable to come up the learning curve on the issue of Reach Codes at the pace that is needed by the climate crisis.

## SMCAT's requested ordinance has been sufficiently studied:

The model reach code for electrification of existing buildings was prepared by a team that included San Mateo and Santa Clara Counties, Peninsula Clean Energy, Silicon Valley Clean Energy and East Bay Community Energy, as well as staff from many of the cities in the County. The model code was fully vetted and reviewed. Why do we need more time or more consultants, organizations and staff to do more outreach and research? Policy experts have already studied the funding from the IRA.

## SMCAT's requested ordinance has undergone a sufficient outreach process:

SMCAT went door to door on a recent weekend, asking residents about the climate. The responses were telling: almost all agree that the climate crisis is real, and that they are looking for leadership to help all San Mateo residents and businesses to take full advantage of the Inflation Reduction Act that offers \$25,000 for every San Mateo family to electrify. Most readily signed our petition.

For the foregoing reasons, we believe that delaying adoption of SMCAT's requested ordinance until 2023 is a disservice to our community and especially our youth, and is a serious and unacceptable delay.

Over 30 community members addressed the City Council at the September 19 Study Session to speak in favor of the City taking urgent action **this year** on existing buildings. Many were youth, who are themselves unable to vote and are thus pleading for their futures with our City's leaders who are in the positions of power. As with the community's pleas at the April and July Sustainability & Infrastructure Commission meetings, and in the Petition for San Mateo Climate Action, now signed by more than 420 climate concerned members of the community, our pleas seem to be supported by City Council yet blocked by city staff from critically needed action on existing building **this year**.

But, it is not too late. We urge you to reconsider. For the sake of our community, our families, and especially our youth, please take critically needed action by adopting SMCAT's requested ordinance **this year**.



Dear Mr. Bonilla,

I am a strong believer in the negative effects of climate change – I donate to many organizations in the hopes that they can find solutions. So understand my position – I do believe that climate change is real so don't even suggest otherwise – I am offended by your comments highlighted in red below!!! I just am asking that the city council consider a compromise.

My gas stove and furnace both use an electric starter, not a pilot light so gas is not being released in my home unless I turn on the appliance. Only my water heater has a pilot light. Also, ovens are often used for longer periods than cooking on cooktops so using gas for the burners and electric for the ovens for longer cooking makes sense.

I am familiar with induction cooktops – I receive Consumer Reports Magazine which occasionally reports on them. BTW, induction cooktops require specific pot materials, some of which I own but would probably have to replace many others which will be expensive. And the PG&E bill I just received for my townhome is composed of \$181.26 electric and \$22.79 for gas. As a retiree would you have me double or triple my monthly expenses when another compromise solution is available? Look at the debate Palo Alto candidates are having now about this and I believe the issue may also be on their ballot. San Mateo didn't get to have a voice in this through a vote.

Why is it so hard to look for a middle ground solution instead of going to an extreme? I don't understand this at all.

Hello Mayor Bonilla, Councilmembers Diaz-Nash and Lee, and other Councilmembers (and candidates),

I read with concern the October 6 Daily Journal Article, "San Mateo is still pushing gas phaseout". I and about 200 other people on NextDoor would like some clarification. Obviously, the article sub-title of "Officials looking at new ordinances to remove appliances starting in 2025" is an eye-grabber. For starters, I am aware of the new San Mateo proposed Reach goals for new construction and for remodels. I am not too alarmed by that, but there are two items in this October 6 article that really alarm me. I will most likely ask these questions on Monday, October 17 at the upcoming City Council meeting as this issue has great public interest. I am sending this in advance so as not to catch you off guard.

The first item that I would like fully clarified is a proposal by the San Mateo Climate Action Team (a volunteer group) that all REPLACEMENT of gas equipment in homes and businesses be electric or zero emissions starting in 2025.

#### From the article:

"At its Oct. 4 special meeting, the council reinforced its desire for city staff to examine the feasibility of a decarbonization plan suggested at a September council meeting by the San Mateo Climate Action Team, a volunteer group working to support climate change actions and solutions. The group asked the city to immediately pass a decarbonization ordinance to address existing buildings' electric appliance replacement. The ordinance would go beyond the city's current and upcoming reach codes, which govern new and used appliance replacement. It also includes a requirement that all replacement of

gas equipment in homes and businesses be electric or zero emissions starting in January 2025. Mayor Rick Bonilla and Councilmember Amourence Lee pushed for immediate action given the state of the climate and public support for stricter requirements."

The final sentence of this paragraph in the article which infers that Mayor Bonilla and Councilmember Lee would support this is concerning. On this first item, the article's language does not seem to be referring to remodels or new construction. It would appear to be referring to ANY event where a gas appliance has failed and needs to be replaced. If this language is accurate, this is very alarming. Replacing an appliance might \$1000-\$5000 (depending on what it is). But the bigger potential issue would be the change in infrastructure to support this. It could result in an unplanned electrical panel upgrade, running 220v wiring, changing kitchen cabinets/flooring/walls if new appliance cannot be found with a matching form factor. It could result in drywall repair and painting. The cost of this would be very difficult to forecast. Hence, I am asking for a clear unambiguous language that states whether you would push or reject any ordinance that would forbid people from replacing a failed natural gas unit with a similar gas unit.

The second item below in the October 6 article that caused me alarm was the sentence:

"The reach codes and decarbonization efforts are part of city goals to decarbonize EXISTING buildings and infrastructure and eliminate methane gas use by 2030." It is unclear to me if this is a Reach goal that has already been agreed upon. But, from this language, this sentence does NOT seem to be referring to new construction or remodels. It seems to infer that ALL gas appliances in ALL buildings need to be removed by 2030. I am hoping that this is just a poor choice of words by the article's author. But, please confirm if this is something that is being considered (or already in place). For this second question, I am specifically asking if you would push or reject an ordinance that demands replacement of gas appliances by 2030.

As a District 1 resident, I am also asking Councilmember Diaz-Nash to be clarify your answers on these two questions. I listened to the Zoom session on October 10 (Transportation and climate) and paid close attention when you were asked this question. Strictly speaking, you did not answer these two questions forcefully enough. Please clarify your answer.

Again, here are the two specific questions that I would like to hear from you as sitting Council

Members (other Council Members or Candidates may also reply if they see fit):

- 1.) I am asking for a clear unambiguous answer that states whether you would push or reject an ordinance that would forbid people from replacing a failed natural gas unit with a similar gas unit after 2025.
- 2.) I am specifically asking if you would push or reject an ordinance that demands replacement of gas appliances by 2030 for existing buildings.

There is quite a lot of fear and confusion as can be seen by the replies on NextDoor (about 200 people in the chat) on this topic. Your answers will be shared so as to clear up the confusion. Personally, I am very concerned about this. While funding/rebates may exist, I find it hard to believe it would be anywhere near the amount totally required to retrofit everyone's wiring infrastructure and/or new appliances. But, maybe as an add-on 3rd question, you could elaborate what pools of funding exist and what the qualifications (income/assets) would be to qualify.
