

COVID-19 Pandemic Recovery

 Lead the establishment of the Sunnyvale CARES Program - leveraging public-private partnerships to provide grants to struggling local small businesses

Public Safety

 Lead the effort to establish a similar Measure C for an update to the REAL Property Transfer Tax for potential funding to crumbling public safety infrastructure

- Initiated discussions to increase water supply and lower water rates for constituents by engaging with regional water entities looking for partnerships with the City's Wastewater Treatment Facility
 - Lead the charge to negotiate a new park through the budget process

- 5. Ensuring the community has my cell phone number on hand



Fairyland Park Discrimination Case

STATE OF MISSOURI BEFORE THE MISSOURI COMMISSION ON HUMAN RIGHT Richard W. Hedges Complainant NO: PA 6/68-194 Fairyland Park Swimming Pool FINDING OF PROBABLE CAUSE On June 16, 1968, a verified complaint was filed by the above complainant with the Missouri Commission on Human Rights alleging that on June 9, 1968, he was allowed to purchase two tickets to gain entrance to the Fairyland Park Swimming Pool. Complainant is a Caucasian. He was accompanied by two Negro friends. They next attempted to purchase tickets, but were not allowed to do so, and were told instead that the pool was a private club. Complainant then asked the ticket seller why he had been sold tickets, since he was and is not a member of the club. The ticket seller then said that an error had been made. Complainant alleges that his acquaintances were not sold tickets because they are Negroes. Thereafter, the Chairman of the Commission designated the undersigned Commissioner to investigate these allegations of the complainant. Based upon the investigation the undersigned Commissioner FINDS AND DETERMINES that: 1. A complaint has been timely filed, to wit, within 90 days after the alleged act of discrimination; 2. Respondent's business is a place of public accommodation within the meaning of Section 314.020, RSMo. Supp. 1965;
