

**AMENDMENT NO. 2 TO THE AGREEMENT
BETWEEN THE CITY OF SAN MATEO AND
TELECOMMUNICATIONS ENGINEERING ASSOCIATES FOR
TELECOMMUNICATIONS MAINTENANCE AND MANAGEMENT SERVICES
(New Amount Not to Exceed \$490,137)**

WHEREAS, the City of San Mateo ("City"), a municipal corporation of the State of California, and Daryl D. Jones, Inc. dba Telecommunications Engineering Associates ("CONTRACTOR"), entered into an Agreement for Telecommunications Maintenance and Management Services ("Agreement") on October 1, 2020; and

WHEREAS, on September 20, 2022, the parties entered into an amendment to the Agreement to increase the maximum agreement amount by \$109,157 to a new amount not to exceed \$364,362 and extend the term through June 30, 2027; and

WHEREAS, City and CONTRACTOR wish to amend the Agreement effective October 1, 2023 to increase compensation by \$125,777 for a new agreement total not to exceed \$490,137.

NOW, THEREFORE, the parties agree as follows:

1. Section 5 of the Agreement is amended to read:
Payment: Payment shall be made by CITY in an amount not to exceed \$490,137 only for services rendered and upon submission of a payment request upon completion and CITY approval of the work performed. In consideration for the full performance of the services set forth in Exhibit A, City agrees to pay CONSULTANT a fee pursuant to the rates stated in Exhibit B2 (revised June 19, 2023), attached and incorporated by reference.
2. The remaining terms of the Agreement remain in full force and effect.
