

**AMENDMENT NO. 1 TO THE AGREEMENT
BETWEEN THE CITY OF SAN MATEO AND
CORPORATE CUISINE, INC., DBA CREEKSIDE GRILL A CALIFORNIA CORPORATION FOR
SENIOR CATERED LUNCH SERVICES**

WHEREAS, the City of San Mateo ("City"), a municipal corporation of the State of California, and ("Corporate Cuisine Inc, DBA Creekside Grill"), entered into an Agreement for Senior Catered Lunch Services ("Agreement") on June 2, 2023; and

WHEREAS, City and Corporate Cuisine Inc, DBA Creekside Grill wish to amend the Agreement effective _____ to increase the price per lunch provide and include the tax applicable for the duration of this Agreement.

NOW, THEREFORE, the parties agree as follows:

Section 5 of the Agreement is amended to read:

Payment shall be made by CITY only for services rendered and upon submission of a payment request upon completion and CITY approval of the work performed. In consideration for the full performance of the services set forth in Exhibit A, CITY agrees to pay CONTRACTOR a fee in an amount of \$11.25-\$12.50 per meal, plus current tax. Total dollar amount per contracted year shall not exceed \$150,000 per fiscal year pursuant to rates stated in Exhibit B, attached and incorporated by reference.

Exhibit B of the Agreement is amended to read:

City shall pay Contractor per meal, delivered as follows:

Contracted Years:

July 1, 2023 – June 30, 2024: \$11.25 per meal, plus current tax

July 1, 2024 – June 30, 2025 \$11.50 per meal, plus current tax

July 1, 2025-June 30, 2026: \$12.00 per meal, plus current tax

Additional Optional Years:

July 1, 2026-June 30, 2027: \$12.25 per meal, plus current tax

July 1, 2027-June 30, 2028: \$12.50 per meal, plus current tax

Total compensation shall not exceed \$150,000 per fiscal year.

2. The remaining terms of the Agreement remain in full force and effect.
