SUBJECT:

Delaware Street Relief Sewer and Underground Flow Equalization System – Interagency Amendment

RECOMMENDATION:

Approve Amendment No. 1 to the Service Agreement with the Peninsula Corridor Joint Powers Board for the Delaware Street Relief Sewer and Underground Flow Equalization System projects in the estimated amount of \$11,210, for a total agreement estimate of \$144,258.96; and authorize the Mayor to execute the amendment in substantially the form presented.

BACKGROUND:

The Basins 2 & 3 Collection System Improvements (Basins 2 & 3) is part of the Clean Water Program and provides important sewer improvements to increase capacity and improve flow management to prevent sanitary sewer overflows in several areas throughout the City. Basins 2 & 3 consists of several construction packages, some of which connect to each other. Both the Underground Flow Equalization System (UFES) and Delaware Street Relief Sewer (Delaware Sewer) projects are part of Basins 2 & 3. The projects, together, are designed to utilize new sewer pipes to convey wet weather flows to the UFES project's 5.3-million-gallon underground wastewater holding structure at the San Mateo County Event Center.

The UFES sewer pipeline alignments are along Saratoga Drive, Delaware Street, and within an easement before entering the Peninsula Corridor Joint Powers Board (JPB) right-of-way to connect to the Delaware Sewer project. The majority of the Delaware Sewer project alignment is within the JPB right-of-way before entering back into the City's public right-of-way at the Delaware Street and Pacific Blvd intersection. The UFES construction started in 2020 and is still in progress. The Delaware Sewer construction contract was recently awarded in February 2020 and construction activities will begin soon.

On June 7, 2021, City Council approved a Service Agreement with the JPB that established a scope and fee for the JPB to review the City's Delaware Sewer project design documents and provide limited oversight and coordination during construction. The original estimated fee of \$133,049 for the Service Agreement was solely focused on the Delaware Sewer project JPB support needs. To facilitate the connection of the UFES and Delaware Sewer projects, the JPB requires further funding for additional administrative and engineering service fees, plus parking fees for the affected parking slots that will be temporarily utilized during the construction to connect the two sewer projects in the JPB right-of-way.

Staff has reviewed the estimate with the JPB and believes it to be reasonable for the scope of services and support provided by the JPB. Staff recommends approval of Amendment No. 1 for the estimated amount of \$11,210.

BUDGET IMPACT:

Funding for Amendment No. 1 to the Service Agreement is available in the Basins 2 and 3 Collection System Improvements project.

ENVIRONMENTAL DETERMINATION:

The work addressed by this administrative report is being undertaken to support the Clean Water Program. This project is subject to the requirements of the California Environmental Quality Act (CEQA), the general components of which are included as part of the Final Programmatic Environmental Impact Report (Final PEIR) (SCH No. 201532006) that was prepared for the Clean Water Program. The Final PEIR was certified by City Council on June 6, 2016.
