2018-19 Street Rehabilitation Phase II Project - Agreement

#### **RECOMMENDATION:**

Approve an agreement with G. Bortolotto & Co., Inc. for the 2018-19 Street Rehabilitation Phase II Project in the amount of \$2,153,469.50; establish a contingency reserve of \$220,000.00; and authorize the Public Works Director to execute the agreement in substantially the form presented and approve contract change orders within the contingency reserve.

#### **BACKGROUND:**

The Public Works Department oversees the Pavement Management Program, which monitors the pavement conditions for all City-maintained streets in San Mateo and implements pavement improvement projects. The 2018-19 Street Rehabilitation Phase II Project (Project) will improve street conditions on segments of Alameda de las Pulgas, East Poplar Avenue, Grand Boulevard, and Pasadena Drive. In addition to street repair, the Project will also add a new bike lane along southbound Alameda de las Pulgas between Madera Drive and 24<sup>th</sup> Avenue.

The project was advertised on April 9, 2019 and bids were opened on May 9, 2019. The bid prices for the four bids received are shown below.

G. Bortolotto & Co., Inc. \$2,153,469.50
Interstate Grading & Paving, Inc. \$2,284,556.00
DeSilva Gates Construction L.P. \$2,389,389.00
O'Grady Paving, Inc. \$2,433,263.00

After review of the bid documents, staff determined that G. Bortolotto & Co., Inc. is the lowest responsible and responsive bidder and recommends approval of the construction agreement. A contingency reserve is included to cover the cost of potential unforeseen conditions that may be encountered during construction.

#### **BUDGET IMPACT:**

Sufficient funds are available for the Project as part of the Citywide Street Rehabilitation FY18-19 Project (467002).

#### **ENVIRONMENTAL DETERMINATION:**

This agreement is categorically exempt from CEQA as an "existing facility" per CEQA Section 15301.
